Historical Note

A resident of Sarasota since he was three months old, Lynn Newman Silvertooth attended Sarasota County schools and graduated from Manatee High School before joining the U. S. Marine Corps and serving in World War II in the South Pacific. After the war, Silvertooth returned to Florida and attended the University of Florida as well as the University of Florida Law School, graduating in 1949. He served Sarasota County as an attorney and judge for the 12th Circuit Court until his retirement in 1988.
