#### Historical Note

John Ringling (1866-1936) is well-known for bringing the circus to Sarasota County, as well as for his work in real estate development and the arts. Ringling moved his circus' winter quarters to Sarasota in 1927 and built a lavish home on Sarasota Bay, which he called Ca'd'Zan, meaning "House of John" in the Venetian dialect of Italian. Married to Mable Burton Ringling (1875-1929), John Ringling spent many years in Sarasota settling into his new home, building up his wealth, and developing various sections of the keys along Sarasota Bay. After Mable's death in 1929, Ringling met Emily Haag Buck (1897-1970) and the two were married in December 1930. The couple divorced in 1935, less than one year before John Ringling's death. Emily Hagg Buck Ringling brought legal proceedings against the estate and relatives of

her deceased husband (particularly John Ringling North and Ida Ringling North) for several years into the early 1940s.
